

Tuition and Fees **2021-2022**

Eagle's Nest tuition is an annual fee that is divided into nine equal monthly installments regardless of the number of program days offered or used. Program operation follows the New Albany-Plain Local Schools school year calendar. There is no tuition adjustment due to holidays, emergency closures, delayed start days, or absences due to vacation, illness, or behavior concerns. If the school is in a hybrid learning mode, students may attend on the days that they are expected on campus, either gold or maroon.

Monthly tuition payments and registration fees are non-transferable. Fees are as follows:

Registration fee (non-refundable, non-transferable): \$50 per child per school year

Payments

Monthly tuition payments are made electronically through PaySchools Central. PaySchools Central allows the family to choose a checking, savings, or credit card account for monthly tuition payments. Parents who wish to share payment responsibilities can establish their own PayForIt accounts. No on-site payments will be accepted.

Late Tuition Payments

Payments are due by the 15th of each month.

Late or unpaid account balances will be charged a \$25.00 late payment fee per occurrence. Repeated late payments or non-payment by the beginning of the following month will result in termination of Eagle's Nest services. After termination, if the family wishes to re-enroll, the student(s) will be placed on the waiting list.

Accounts must be paid in full in order to participate in Eagle's Nest in subsequent school years.

Late Pickup Fee

A late fee of \$5.00 will be assessed for each portion of a 5-minute interval after 6:00 p.m. that a child is not picked up. Fees will be charged to your existing PaySchools Central account and

must be paid in full within five (5) business days of the occurrence. Frequent late pick-ups will result in increased fees and/or termination of eligibility for Eagle’s Nest services. After termination, the student(s) will be placed on the waiting list. All past due fees must be paid in order to re-enroll.

Change in Care

- Contract changes require a minimum notification of 15 days prior to the next tuition payment due date.
- A family may change care arrangements if there is space available within the program. If space is not available at the time of request, the student(s) can be placed on a waiting list.
- A contract change fee of \$30.00 will be charged for each occurrence of care change within the same school year.
- Change in tuition will take effect based on the date of notification.

Withdrawal

Withdrawal from Eagle’s Nest must be made in writing to eaglesnest@napls.us with notification 15 days prior to the next tuition due date. Please note the following:

- **Program withdrawals prior to the start of the school year must be made by August 1st at 3 pm EST in order to avoid the first month’s tuition charges.**
- Notifications provided less than 15 days before the next tuition due date will result in either a partial charge or a partial refund.
- No refunds will be given for the following time periods:
 - November 15th - January 14th
 - May 15th - end of school year

Students may be re-enrolled if space is available. A re-enrollment fee of \$50 is required each time a student rejoins the program.
